Offender Clients only:

- 1) Use individual income of primary financial provider for the family. (Income includes all income as defined under Internal Revenue Code (Wages, Alimony, etc.) as well as SSI, Social Security, (not child support, TANF).
- 2) Offender Client MUST supply proof of income to reduce fee (W -2, profit/loss, paystub, tax returns, etc.) Offender Clients who do not provide proof of income will be charged standard treatment rates.
- 3) Offender Clients on disability, SSI less than \$500 per month will be charged per SSI scale above, WITH proof of disability.
- 4) Offender Clients not referred by the court will be charged \$10.00 per session.
- 5) Offender Clients who are unemployed will pay a minimum rate of \$10.00 per session for one month only. **Please re-verify income after 30 days.**
- 6) OFFENDER CLIENTS WHO ARE REFERRED BACK TO COURT FOR NONCOMPLIANCE ARE NO LONGER ELIGIBLE FOR FEE REDUCTION AND MUST PAY STANDARD TREATMENT RATE (NO EXCEPTIONS).
